**Local public consultation - Have your say**

**Cartmel Post Office  
Cartmel Ground Art Gallery, Cavendish Street,  
Cartmel, Grange Over Sands, LA11 6QA**

We are moving the above Post Office service to a new location - Boutique Stays at Cartmel Square, The Square, Cartmel, Grange Over Sands, LA11 6QB.

**Why are we moving?**

The premises will no longer be available for Post Office use and the current service at Cartmel Ground Art Gallery will cease from Thursday 30 June 2022 at 13:00.

We have therefore had to identify an alternative location to continue to offer Post Office services to the local community.

We are pleased to let you know that the current postmaster from Grange Over Sands Post Office will continue to operate this service from the new premises at Boutique Stays at Cartmel Square and this service will commence from Tuesday 5 July 2022 at 09:30.

Our priority is to safeguard our services in the locality in the longer term. Our postmaster firmly believes that the move will help secure continued access to Post Office services locally.

**We'd like your help**

Whilst the decision has already been made to move this service, on Tuesday 5 July 2022, we would still like your views on access and the service offer at the new location. Therefore, we're now commencing a local public consultation and before we finalise our plans would like to hear your views, particularly around the following questions:

**What exactly are we consulting on?**

We'd welcome your comments on the following areas:

- **Are the new premises easy for you to get into and is the inside easily accessible?**
- **Are there any other local community issues which you believe could be affected by or affect the change?**
- **Is there anything we could do to make it easier for customers?**

In order to maintain a Post Office service to our customers in Cartmel, the new Post Office service is due to open on Tuesday 5 July 2022 at Boutique Stays at Cartmel Square. However, this does not affect the period of public consultation which is ongoing until Tuesday 2 August 2022.

- Customers will access Post Office services from within the Boutique Stays at Cartmel Square.
- The Post Office service will be located in a dedicated area within the new premises.
- The Post Office will continue to offer the same range of products and services with the same opening times.
- Posters and leaflets will now be displayed in the Cartmel Ground Art Gallery and the Boutique Stays at Cartmel Square to let customers know about the change and to ask their views.
- Any information we receive will be carefully considered as we finalise our plans.
- If you are a local representative, we will write to you again at the end of the consultation to respond to the main issues raised and to explain our final plans for the branch.
- This consultation is being carried out in line with our Principles of Community Engagement which have been agreed with Citizens Advice, Citizens Advice Scotland and the General Consumer Council for Northern Ireland - the independent statutory consumer watchdogs. An extract relating to Consultation is available at the end of this letter.

If you are a local representative, it would be helpful if you could share this information through your social media channels and with any local groups or organisations that you know within the community, for example on noticeboards, local charities and in GP surgeries, to help our customers and your constituents understand what is happening to Cartmel Post Office. ## **Principles of Community Engagement on changes to the Post Office network (extract)**

We are committed to engaging and supporting our customers and their representatives as we make changes to the Post Office network. The following principles will be adopted when communicating about changes to your local Post Office branch.

We will **Consult** where we are seeking feedback on proposals prior to a decision being made on the:

- Permanent closure of a Post Office branch<sup>1</sup>
- Permanent relocation of a Post Office branch (including the franchising of a Directly Managed branch to a new site)

We will carry out a six-week<sup>2</sup> local public consultation, informing customers, locally elected representatives<sup>3</sup>, Consumer Advocacy Bodies and selected charities<sup>4</sup> of the proposal. This information will also be made available online and for a Directly Managed branch a press release will be issued to local media. We will ask locally elected representatives to share information with other key community outlets (such as notice boards, local charities, magazines, GP surgeries etc.).

The consultation will ask specific questions on areas where we would like feedback on access to Post Office services and will confirm when the change will happen if the decision is made to proceed. We will provide clear information on any changes to services as well as access to and into the new branch.

We welcome all feedback with the following factors being taken into account in making our decision, which we expect to make within four weeks of the close of consultation:

- Customer access to, into and inside the new or alternative branch/branches with particular regard to vulnerable consumers
- Any local community issues which could be affected by or affect the proposal

At the end of the consultation process we will write to locally elected representatives, Consumer Advocacy Bodies and respondents to the consultation (where practical) to confirm our decision and provide a summary of key issues raised with a clear response to each. This information will be made available online and in branch (where possible).

What to do if you feel these Principles haven't been followed:

Please get in touch so we can investigate your complaint. We'll explain in our reply whether we believe we have followed our Principles of Community Engagement and will provide you with the contact details for the relevant consumer watchdog (Citizens Advice, Citizens Advice Scotland or the Consumer Council for Northern Ireland) if you're not satisfied with our response. The watchdog will independently assess whether we have followed the Principles of Community Engagement process (rather than the decision itself) and recommend any actions with respect to the complaint.

<sup>1</sup> There may be a small number of cases where due to circumstances outside our control we have no option other than to permanently close a branch in a particular location. In these cases, the consultation will seek feedback on alternative Post Office service provision in the area.

<sup>2</sup> If the consultation includes more than four weeks in July in Scotland and Northern Ireland or more than four weeks in August in England and Wales, we will extend the period by one calendar week. We will not start any local public consultation during the two-week period which includes the Christmas and New Year bank holidays.

<sup>3</sup> Locally elected representatives include but are not restricted to the Member of Parliament, Scottish Parliament, Welsh Parliament, or Northern Ireland Assembly, Local Authority Chief Executive, Ward Councillors, Parish or Community Council.

<sup>4</sup> Selected charities are local Citizens Advice, Age UK, Northern Ireland's Disability Action and Northern Ireland's Rural Community Network. All parties referred to in <sup>3</sup> and <sup>4</sup> above are encouraged to share all information with local groups and organisations who they believe have an active interest in changes to their local Post Office.
