Corn Exchange Post Office® India Building, Water Street, Liverpool, L2 ORR

Local Public Consultation Decision

I am writing to confirm that after careful consideration of the feedback received, and all other relevant factors, we have decided that there is sufficient access to alternative Post Office services to cope with demand in the area following the closure of Corn Exchange branch.

As you will recall from my previous letter, we've been notified by our landlord that they intend to redevelop the above premises and as a consequence Corn Exchange Post Office will have to close. The closure is outside our control as the landlord will be taking back the premises. Taking into account the level of Post Office service provision in the area, we are satisfied that customers will continue to be able to access Post Office services. However, we remain committed to re-establishing a service in the business area of the city but are not able to do so at this time.

Our decision

We've considered the feedback received during consultation from customers and local representatives very carefully, particularly the concerns raised around future accessibility of our services. With any closure it's inevitable, but regrettable, that some customers will be inconvenienced.

However, with Liverpool Post Office located just 450 metres away from Corn Exchange Post Office and a further four branches, Central Village, Monument Place, Eldonian Village, and Low Hill within 2 miles, the surrounding area is well served by Post Office services. There is also sufficient capacity at these branches to accommodate any additional footfall following the change, helping to make sure that local customer needs will continue to be met. I can now also confirm that following the closure of Corn Exchange branch, Biometric Enrolment services for the Home Office will relocate to Liverpool Branch.

While we are confident that there are enough Post Offices in the local area to meet the needs of customers, as previously explained, we will continue to search for opportunities to re-establish Post Office services in the business area, including advertising for interest in opening more smaller branches in the area so that we can respond to our customers' needs for greater convenience in locations and extended opening hours to fit in with their busy lives.

Public consultation responses

During the 12 week local consultation period we received 37 individual representations. All the feedback we received helped us to better understand the views of customers and their representatives and I would like to thank everyone who took the time to let us have their comments and provide information.

Much of the feedback we received focused on the impact of additional customers on Liverpool branch, the distance and journey to the alternative branches, accessibility and the inconvenience to local businesses.

Access to Post Office services

We recognise that some customers may be inconvenienced by the change, which may mean they have a longer journey and wait for access to Post Office services. However, there are a number of alternative Post Office branches in the surrounding area and there is good public transport provision. From our analysis we expect that most customers and local businesses currently using Corn Exchange would use the closest branch, Liverpool, but recognise that others may choose to use one of the next four closest - Central Village, Monument Place, Eldonian Village, and Low Hill.

For customers who choose to walk, Liverpool branch is located approximately 450 metres away along varied terrain from the current branch with dropped kerbs and pedestrian crossings en route. Central Village, Monument Place, Eldonian Village, and Low Hill are all within 2 miles along varied terrain.

Liverpool, Central Village, Monument Place, Eldonian Village, and Low Hill all offer a comprehensive range of services and products. Monument Place and Eldonian Village branches both have external Post Office cash machines, where personal banking and Post Office Card Account holders can withdraw cash 24 hours a day.

We are satisfied that all of the alternative branches have sufficient capacity to absorb additional business and meet the needs of local businesses and personal customers but remain committed to re-establishing Post Office services in the business area. Additionally, we are working closely with the operator at Liverpool, the closest branch, to make sure that they are ready to meet the additional footfall and maintain quality of service. There are plans to increase the number of staff and we also plan to introduce three additional self-service machines at Liverpool branch. To ensure customer needs are met, we will closely monitor waiting time and usage at the branch.

I remain satisfied that customers in Liverpool will continue to have good access to Post Office services. Further information about the alternative branches in the area are given in the information sheet at the end of this letter.

In respect of our people working at Corn Exchange branch, we have a strong track record of supporting our people through change and we will do all that we can to find a solution that works for each individual within the options available.

Conclusion

It's clear that the Post Office plays an important part in the lives of our customers living and working in the area and we want to make our services as accessible as possible. Without doubt the Post Office has a special position in the community.

I am confident that the remaining branches in the area will meet customer needs both now and in the future; ensuring residents have continued access to Post Office services while delivering an excellent service.

Posters will now be displayed in branch to let customers know about this decision. The branch will cease trading from 17:30 on Wednesday 23 May 2018.
