Local public consultation - Have your say

Duncairn Street Post Office 240 Antrim Road, Belfast, BT15 2AR

We are proposing to move the above Post Office branch to a new location – Spar Stores, 135 Crumlin Road, Belfast, BT14 6AD, where it would operate as one of our local style branches.

Why are we proposing this move?

We're proposing this move as part of the ongoing modernisation of our branch network. We are confident that introducing a local style branch alongside a successful retail store is the most effective way to safeguard sustainable Post Office services in the local community into the future.

We'd like your help

We're now starting a period of local public consultation and your feedback is important to us as it will help to inform our decision. For more details of the proposed services and accessibility, please see the branch information summary later in this consultation document.

What exactly are we consulting on?

We'd welcome your comments on the following areas:

- How easy is it to get to the proposed new location?
- Are the new premises easy for you to get into and are they easily accessible once inside?
- Are there any other local community issues which you believe could be affected by or affect the proposed Post Office move?
- If the move were to proceed, is there anything we could do to make it easier for customers?

Please note the proposed change of management of the branch is a decision for Post Office Ltd and therefore we are not seeking feedback on this aspect of the change.

Good to know

- Customers would access Post Office services at two low-screened, open-plan, modern serving points that's part of the retail counter.
- Working with the postmaster, we'd adapt the current store layout, fixtures, and fittings to accommodate the Post Office till if needed.
- At the proposed premises there would be a dedicated customer car park for up to twenty cars located outside the store.
- There would be a designated disabled parking bay outside the front of the shop, which would be clearly marked.
- Additionally, there is a marked pedestrian walkway, from the pavement in front of the forecourt to provide safe access to the entrance of the proposed premises.
- The Post Office would offer a range products and services over longer opening hours so customers can access their branch when it's convenient. Customer satisfaction with local style branches is high, and many customers visit outside traditional opening hours.
- All staff employed to work in the proposed new branch would be trained to the highest standards with on-going training on products and services, as well as operational and service-related matters.
- Posters and leaflets will now be displayed in branch to let customers know about the proposal and to ask their views.
- Any information we receive will be carefully considered as we finalise our plans.
- If you are a local representative, we will write to you again at the end of the consultation to respond to the main issues raised and to explain our final plans for the branch.
- This consultation is being carried out in line with our Principles of Community Engagement which have been agreed with Citizens Advice, Citizens Advice Scotland and the General Consumer Council for Northern Ireland the independent statutory consumer watchdogs. An extract relating to Consultation is available at the end of this letter.

Products & Services

A range of products and services would still be available, with the addition of Euros and Dollars Travel Money, however excluding a comprehensive range of Travel Money, Passport Check & Send, On Demand Travel Insurance, and National Lottery. We would not be transferring the Cash Machine at the proposed premises.

Serving positions

There would be two Post Office serving points at the retail counter.

Access

Access would be level with automatic doors at the entrance to the proposed premises. Internally, there would a hearing loop and space for a wheelchair.

There is a marked pedestrian walkway, from the pavement in front of the forecourt to provide safe access to the entrance of the proposed premises.

Getting there

The proposed new branch would be located approximately 0.8 miles away from the current branch, along varied terrain.

There would be a dedicated customer car park for up to twenty cars located outside the proposed premises.

There would be a designated disabled parking bay outside the front of the shop, which would be clearly marked.

Principles of Community Engagement on changes to the Post Office network (extract)

We are committed to engaging and supporting our customers and their representatives as we make changes to the Post Office network. The following principles will be adopted when communicating about changes to your local Post Office branch.

We will **Consult** where we are seeking feedback on proposals prior to a decision being made on the:

- Permanent closure of a Post Office branch¹
- Permanent relocation of a Post Office branch (including the franchising of a Directly Managed branch to a new site)

We will carry out a six-week² local public consultation, informing customers, locally elected representatives³, Consumer Advocacy Bodies and selected charities⁴ of the proposal. This information will also be made available online and for a Directly Managed branch a press release will be issued to local media. We will ask locally elected representatives to share information with other key community outlets (such as notice boards, local charities, magazines, GP surgeries etc.).

The consultation will ask specific questions on areas where we would like feedback on access to Post Office services and will confirm when the change will happen if the decision is made to proceed. We will provide clear information on any changes to services as well as access to and into the new branch.

We welcome all feedback with the following factors being taken into account in making our decision, which we expect to make within four weeks of the close of consultation:

- Customer access to, into and inside the new or alternative branch/branches with particular regard to vulnerable consumers
- Any local community issues which could be affected by or affect the proposal

At the end of the consultation process we will write to locally elected representatives, Consumer Advocacy Bodies and respondents to the consultation (where practical) to confirm our decision and provide a summary of key issues raised with a clear response to each. This information will be made available online and in branch (where possible).

These Principles have been agreed with Citizens Advice, Citizens Advice Scotland and the General Consumer Council for Northern Ireland; the independent statutory consumer watchdogs.

What to do if you feel these Principles haven't been followed:

Please get in touch so we can investigate your complaint. We'll explain in our reply whether webelieve we have followed our Principles of Community Engagement and will provide you with the contact details for the relevant consumer watchdog (Citizens Advice, Citizens Advice Scotland or the Consumer Council for Northern Ireland) if you're not satisfied with our response. The watchdog will independently assess whether we have followed the Principles of Community Engagement process (rather than the decision itself) and recommend any actions with respect to the complaint.

There may be a small number of cases where due to circumstances outside our control we have no option other than to permanently close a branch in a particular location. In these cases, the consultation will seek feedback on alternative Post Office service provision in the area.

² If the consultation includes more than four weeks in July in Scotland and Northern Ireland or more than four weeks in August in England and Wales, we will extend the period by one calendar week. We will not start any local public consultation during the two-week period which includes the Christmas and New Year bank holidays.

³ Locally elected representatives include but are not restricted to the Member of Parliament, Scottish Parliament, Welsh Parliament, or Northern Ireland Assembly, Local Authority Chief Executive, Ward Councillors, Parish or Community Council.

⁴ Selected charities are local Citizens Advice, Age UK, Northern Ireland's Disability Action and Northern Ireland's Rural Community Network. All parties referred to in ³ and ⁴ above are encouraged to share all information with local groups and organisations who they believe have an active interest in changes to their local Post Office.
