

## Dear Customer,

I'm pleased to let you know that we will be trialling a new type of Post Office branch in your area at Your Local Convenience Store, 12 Earls Hall Parade, Prince Avenue, Southend-On-Sea, SS2 6NW commencing on Friday 31 March at 13:00.

In order to strengthen the network and enhance its commercial sustainability, we have developed a lighter, flexible branch format called Drop & Collect. Drop & Collect has been developed to make it easier for postmasters – existing and new – to take advantage of the opportunities a vibrant, and increasingly competitive, parcels market offers. Consumer shopping habits have been changing and the popularity of online shopping has transformed the parcels market at pace. This new format will also help us address gaps in service coverage, ensuring that we have the best network for parcels across all parts of the UK. This will strengthen the Post Office brand and enhance the ability to compete for additional business from new carriers for the wider network.

We have been trialling Drop & Collect in several locations across the UK. The trials have provided us with the opportunity to refine the proposition before the format is introduced across the network. The initial pilots have been in Payzone stores, offering customers Payzone's bill payments services combined with collections, returns and prepaid parcel services. The proposition is now being extended to our retail partners with plans to eventually broaden the proposition to our existing postmasters.

The new format at Your Local Convenience Store, will offer Post Office services from a handheld device, providing convenient access for customers to bill payments and prepaid parcel collections and returns. To maximise accessibility to these services that our customers are increasingly seeking, more complex services like personal and business banking will not be available at this branch. Details of the opening hours and the products and services available are provided overleaf. If there are any unforeseen circumstances which mean the opening date changes, posters will be displayed in store to let customers know.

A wider range of Post Office services are available at Eastbourne Grove Post Office, 80 Eastbourne Grove, Westcliff-on-Sea, SS0 0QF and Eastern Avenue Post Office, Waitrose, Fossetts Way, Eastern Avenue, Southend-on-Sea, SS2 4DQ. During the trial of the new branch format, we will monitor usage, suitability and any local feedback. If there is a need to change the service, posters will be displayed locally to let customers know.

## Principles of Community Engagement on changes to the Post Office network (extract)

We are committed to engaging and supporting our customers and their representatives as we make changes to the Post Office network. The following Principles will be adopted when communicating about changes to your local Post Office branch.

We will **<u>Notify</u>** - where we are informing customers of changes around:

- Opening hours
- Temporary closure<sup>1</sup>/ temporary service interruption
- Re-opening of a temporarily closed branch in the same site
- Opening a new branch unrelated to a previous closure
- Location used by a Mobile Post Office within a community

We will display a poster in branch (or nearby if appropriate) to notify customers of the above changes, providing four weeks' notice. Where four weeks' notice is not possible, we will provide notice as soon as we are able to. For temporary closures we will include details of the nearest alternative Post Offices and our customer helpline/textphone.

## These Principles have been agreed with Citizens Advice, Citizens Advice Scotland and the General Consumer Council for Northern Ireland; the independent statutory consumer watchdogs.

What to do if you feel these Principles haven't been followed:

Please get in touch so we can investigate your complaint. We'll explain in our reply whether webelieve we have followed our Principles of Community Engagement and will provide you with the contact details for the relevant consumer watchdog (Citizens Advice, Citizens Advice Scotland or the Consumer Council for Northern Ireland) if you're not satisfied with our response. The watchdog will independently assess whether we have followed the Principles of Community Engagement process (rather than the decision itself) and recommend any actions with respect to the complaint.

<sup>1</sup> There may be a small number of cases where due to circumstances outside our control we have no option other than to permanently close a branch in a particular location. In these cases, the consultation will seek feedback on alternative Post Office service provision in the area.

We notify locally elected representatives including but are not restricted to the Member of Parliament, Scottish Parliament, Welsh Parliament, or Northern Ireland Assembly, Local Authority Chief Executive, Ward Councillors, Parish or Community Council, selected charities, local Citizens Advice, Age UK, Northern Ireland's Disability Action and Northern Ireland's Rural Community Network. They are also encouraged to share all information additionally with local groups and organisations who they believe have an active interest in changes to their local Post Office.
