## **Local public consultation - Have your say**

**Hyde Post Office**  
**30-32 Market Place, Hyde, SK14 2QU**

We are writing to advise that our retail partner, Firstclass Managerial Ltd, has found a nearby alternative premises from which to operate Hyde Post Office branch and we are proposing to relocate the branch to 33-35 Market Place, Hyde, SK14 2LX (formerly Oakland Furnishings). The same services would be available, and opening hours would be unchanged. The proposed premises are currently empty, however, if the move goes ahead, the proposed new premises would undergo a full refurbishment to incorporate a cards and stationery shop alongside Hyde Post Office, subject to consultation.

### **Why are we proposing this move?**

As you may be aware, our retail partner operates Post Office branches alongside their private retail business, and it is important that they make the very best use of their resources to ensure future sustainability of both their business and the Post Office service. In this case, our partner has identified an opportunity to move this branch into modern premises whilst continuing to offer Post Office services to the local area. Our priority is to safeguard our services and we are confident that the proposed move of Hyde Post Office branch will deliver longer-term service provision to the local community.

### **We'd like your help**

We're now starting a period of local public consultation and your feedback is important to us as it will help to inform our decision. For more details of the proposed services and accessibility, please see the branch information summary later in this consultation document.

### **What exactly are we consulting on?**

We'd welcome your comments on the following areas:

- **How easy is it to get to the proposed new location?**
- **Are the new premises easy for you to get into and are they easily accessible once inside?**
- **Are there any other local community issues which you believe could be affected by or affect the proposed change?**
- **If the move were to proceed, is there anything we could do to make it easier for customers?**

## Good to know

- Post Office is delivering an ambitious, five-year Transformation Plan to 2030 designed to secure a modern, trusted and financially sustainable national network. The plan focuses on strengthening our offer to consumers and small businesses, modernising our branches and technology, simplifying the operating model and resetting relationships with postmasters and stakeholders, improving long-term branch viability while protecting the Post Office's social purpose. - Any independent franchise retail partner, including Firstclass Managerial Ltd, must have a clear track record of successfully running Post Office services, or similar customer-orientated retail ensuring they can deliver an excellent service to the community. Firstclass Managerial Ltd operate twenty-one thriving Post Office branches nationally including eleven across Greater Manchester, most of which are large, branches offering a wide range of Post Office services.
- Working with our retail partner, we'd adapt the current store layout, fixtures and fittings to accommodate the Post Office. It would be in a dedicated area of the store with three open plan positions and one screened, over the same opening hours.
- The Post & Go service (Self-Service Kiosk) would not be available, however there would be a Drop Box. This is a new self-serve parcel drop-off facility enabling fast, secure, pre-paid drop-offs in branch and will deliver a simpler, reduced queuing solution for customers across multiple drop-off services.
- The same staff would be employed to work in the proposed new branch and would continue to be trained to the highest standards with on-going training on products and services, as well as operational and service-related matters.
- We have stringent standards to ensure good access for all customers and our plans for the proposed new branch include low-level counters and PIN pads.
- Posters and leaflets will now be displayed in branch to let customers know about the proposal and to ask their views.
- Any information we receive will be carefully considered as we finalise our plans.
- If you are a local representative, we will write to you again at the end of the consultation to respond to the main issues raised and to explain our final plans for the branch.
- This consultation is being carried out in line with our Principles of Community Engagement which have been agreed with Citizens Advice, Consumer Scotland and the General Consumer Council for Northern Ireland - the independent statutory consumer advocacy bodies. An extract relating to Consultation is available at the end of this letter.

If you are a local representative, it would be helpful if you could share this information through your social media channels and with any local groups or organisations that you know within the community, for example on noticeboards, local charities and in GP surgeries, to help our customers and your constituents understand the changes we are proposing to Hyde Post Office. ## **Principles of Community Engagement on changes to the Post Office network (extract)**

**We are committed to engaging and supporting our customers and their representatives as we make changes to the Post Office network. The following Principles will be adopted when communicating about changes to your local Post Office branch.**

We will **Consult** - where we are seeking feedback on proposals prior to a decision being made on the:

- Permanent closure of a Post Office branch<sup>5</sup>
- Permanent relocation of a Post Office branch (including the franchising of a Directly Managed branch to a new site)

We will carry out a six-week<sup>6</sup> local public consultation, informing customers, locally elected representatives, Consumer Advocacy Bodies, and selected charities of the proposal. This information will also be made available online and for a Directly Managed branch a press release will be issued to local media. We will ask locally elected representatives to share information with other key community outlets (such as notice boards, local charities, magazines, GP surgeries etc.).

The consultation will ask specific questions on areas where we would like feedback on access to Post Office services and will confirm when the change will happen if the decision is made to proceed. We will provide clear information on any changes to services as well as access to and into the new branch.

We welcome all feedback with the following factors being taken into account in making our decision, which we expect to make within four weeks of the close of consultation:

- Customer access to, into and inside the new or alternative branch/branches with particular regard to vulnerable consumers
- Any local community issues which could be affected by or affect the proposal

At the end of the consultation process we will write to locally elected representatives, Consumer Advocacy Bodies, and respondents to the consultation (where practical) to confirm our decision and provide a summary of key issues raised with a clear response to each. This information will be made available online and in branch (where possible).

**These Principles have been agreed with Citizens Advice, Consumer Scotland and the General Consumer Council for Northern Ireland, the independent statutory consumer advocacy bodies.**

### What to do if you feel these Principles haven't been followed:

Please get in touch so we can investigate your complaint. We'll explain in our reply whether we believe we have followed our Principles of Community Engagement and will provide you with the contact details for the relevant consumer advocacy body (Citizens Advice, Consumer Scotland, or the Consumer Council for Northern Ireland) if you're not satisfied with our response. The consumer advocacy body will independently assess whether we have followed the Principles of Community Engagement process (rather than the decision itself) and recommend any actions with respect to the complaint.

<sup>5</sup> There may be a small number of cases where due to circumstances outside our control we have no option other than to permanently close a branch in a particular location. In these cases, the consultation will seek feedback on alternative Post Office service provision in the area.

<sup>6</sup> If the consultation includes more than four weeks in July in Scotland and Northern Ireland or more than four weeks in August in England and Wales, we will extend the period by one calendar week. We will not start any local public consultation during the two-week period which includes the Christmas and New Year bank holidays.
