

# Your new branch is due to open

# Mapplewell Post Office Premier Store, 22 Towngate, Mapplewell, Barnsley, S75 6AT

We recently asked your views on some key areas about our plans to restore the Post Office service in the local community. We received twenty-two responses and we are opening the branch on Friday 29 July 2022 at 13:00.

## Key points raised:

- Parking
- Space inside the store
- Access into the new premises

#### Response to key points:

## **Parking**

Parking and the availability of parking spaces are problems faced generally in many locations nationwide. Whilst there is no parking available directly outside the branch, a further review of parking has been carried out and has confirmed that on street parking is available within 100 metres.

#### Space inside the store and internal layout

We have worked closely with our new operator to make sure there is sufficient space for Post Office customers, including wheelchair users, so that they can move around the store and reach the Post Office area easily. Some internal adjustments to fixtures and fittings will be made to accommodate this.

#### Access into the new premises

We are mindful of the needs of all our customers, including those with mobility concerns. The new premises has a wide door. There is a step at the entrance, however a bell has been provided at the entrance to the new premises and a portable ramp is available on request.

We do hope that you will enjoy using the new Post Office.

## Principles of Community Engagement on changes to the Post Office network (Extract)

We are committed to engaging and supporting our customers and their representatives as we make changes to the Post Office network. The following Principles will be adopted when communicating about changes to your local Post Office branch.

We will **Engage** - where we are seeking feedback on a decision that has been made on:

- Re-opening of a temporarily closed branch in a new location (where the branch has been closed for
  - more than three months)
- Franchising of a Directly Managed branch in its existing site

While the decision to proceed will have already been made, we will welcome suggestions about specific aspects of the change such as access arrangements and the internal layout. We will provide four weeks' notice or, where extenuating circumstances prevent this, we will provide as much notice as possible.

During this period we will display a poster in branch and provide information online. We will contact locally elected representatives<sup>2</sup>, the Consumer Advocacy Bodies and selected charities<sup>3</sup>, providing clear information on any changes to services or access arrangements at the branch. We will ask locally elected representatives to share information with other key community outlets (such as notice boards, local charities, magazines, GP surgeries etc.). We will publish the outcome of the engagement online and in branch, providing a summary of key issues raised with a clear response to each and any changes made to our original plans.

These Principles have been agreed with Citizens Advice, Citizens Advice Scotland and the General Consumer Council for Northern Ireland; the independent statutory consumer watchdogs.

What to do if you feel these Principles haven't been followed:

Please get in touch so we can investigate your complaint. We'll explain in our reply whether we believe we have followed our Principles of Community Engagement and will provide you with the contact details for the relevant consumer watchdog (Citizens Advice, Citizens Advice Scotland or the Consumer Council for Northern Ireland) if you're not satisfied with our response. The watchdog will independently assess whether we have followed the Principles of Community Engagement process (rather than the decision itself) and recommend any actions with respect to the complaint.
