**Local public consultation - Have your say**

**Pontycymmer Post Office**  
**6 Oxford Street, Pontycymmer, Bridgend, CF32 8DA**

We are proposing to move the above Post Office branch to a new location - Smart Lettings, 50A Oxford Street, Pontycymer, Bridgend, CF32 8DB, where it would operate as one of our local style branches.

**Why are we proposing this move?**

We're proposing this move as part of the ongoing modernisation of our branch network. We are confident that introducing a local style branch alongside a successful retail store is the most effective way to safeguard sustainable Post Office services in the local community into the future.

As you may be aware, this branch has been operated on our behalf by a temporary postmaster. Whilst this arrangement has enabled us to maintain access to Post Office services to our customers in the area, we have now identified an alternative location to continue to offer Post Office services to the local community. We are pleased to inform you that a new agent has been appointed and would operate the Post Office service from the new premises.

Our priority is to safeguard our services in the locality in the longer term and the relocation of Pontycymmer Post Office would enable us to maintain a Post Office service to our customers within the local community.

**We'd like your help**

We're now starting a period of local public consultation and your feedback is important to us as it will help to inform our decision. For more details of the proposed services and accessibility, please see the branch information summary later in this consultation document.

**What exactly are we consulting on?**

We'd welcome your comments on the following areas:

- **How easy is it to get to the proposed new location?**
- **Are the new premises easy for you to get into and are they easily accessible once inside?**
- **Are there any other local community issues which you believe could be affected by or affect the proposed Post Office move?**
- **If the move were to proceed, is there anything we could do to make it easier for customers?**

Please note the proposed change of management of the branch is a decision for Post Office Ltd and therefore we are not seeking feedback on this aspect of the change.

## Good to know

- There is a step with a wide door at the entrance to the proposed premises. The new agent would look to improve access and would provide a portable entrance ramp with handrails to help customers with mobility issues or wheelchair users, get into the proposed premises. To let customers know that the portable ramp is available, there would be a clearly visible sign at the entrance of the new premises explaining how to request the ramp. There would also be a bell for people to ring for assistance and both this and the sign would be accessible to wheelchair users. Staff would respond promptly to any requests.
- Working with the postmaster, we'd adapt the current Estate Agents internal layout, fixtures and fittings to accommodate the Post Office till if needed. Customers would access Post Office services at a low-screened, open-plan, modern serving point that's part of the retail counter.
- The Post Office would offer a similar range of products and services over longer opening hours so customers can access their branch when it's convenient. Customer satisfaction with local style branches is high, and many customers visit outside traditional opening hours.
- All staff employed to work in the proposed new branch would be trained to the highest standards with on-going training on products and services, as well as operational and service-related matters.
- Posters and leaflets will now be displayed in branch to let customers know about the proposal and to ask their views.
- Any information we receive will be carefully considered as we finalise our plans.
- If you are a local representative, we will write to you again at the end of the consultation to respond to the main issues raised and to explain our final plans for the branch.
- This consultation is being carried out in line with our Principles of Community Engagement which have been agreed with Citizens Advice, Citizens Advice Scotland and the General Consumer Council for Northern Ireland - the independent statutory consumer watchdogs. An extract relating to Consultation is available at the end of this letter.

If you are a local representative, it would be helpful if you could share this information through your social media channels and with any local groups or organisations that you know within the community, for example on noticeboards, local charities and in GP surgeries, to help our customers and your constituents understand the changes we are proposing to Pontycymmer Post Office. ### Products & Services

A similar range of products and services would still be available, however excluding On Demand Travel Insurance.

### Serving positions

There would be a Post Office serving point, located in a dedicated area within the Estate Agents premises.

### Access

Currently, there is a wide door and a step at the entrance to the proposed premises. However, the new agent would provide a portable entrance ramp with handrails to help customers with mobility issues or wheelchair users, get into the proposed premises. To let customers, know that the portable ramp is available, there would be a clearly visible sign at the entrance of the new premises explaining how to request the ramp. There would also be a bell for people to ring for assistance and both this and the sign would be accessible to wheelchair users. Staff would respond promptly to any requests. Internally, there would be a hearing loop.

### Getting there

The proposed new branch would be located approximately 180 metres away from the current branch, along varied terrain.

Time restricted roadside parking would be available along Oxford Street, with designated disabled parking bays.

## **Principles of Community Engagement on changes to the Post Office network (extract)**

We are committed to engaging and supporting our customers and their representatives as we make changes to the Post Office network. The following principles will be adopted when communicating about changes to your local Post Office branch.

We will **Consult** where we are seeking feedback on proposals prior to a decision being made on the:

- Permanent closure of a Post Office branch<sup>1</sup>
- Permanent relocation of a Post Office branch (including the franchising of a Directly Managed branch to a new site)

We will carry out a six-week<sup>2</sup> local public consultation, informing customers, locally elected representatives<sup>3</sup>, Consumer Advocacy Bodies and selected charities<sup>4</sup> of the proposal. This information will also be made available online and for a Directly Managed branch a press release will be issued to local media. We will ask locally elected representatives to share information with other key community outlets (such as notice boards, local charities, magazines, GP surgeries etc.).

The consultation will ask specific questions on areas where we would like feedback on access to Post Office services and will confirm when the change will happen if the decision is made to proceed. We will provide clear information on any changes to services as well as access to and into the new branch.

We welcome all feedback with the following factors being taken into account in making our decision, which we expect to make within four weeks of the close of consultation:

- Customer access to, into and inside the new or alternative branch/branches with particular regard to vulnerable consumers
- Any local community issues which could be affected by or affect the proposal

At the end of the consultation process we will write to locally elected representatives, Consumer Advocacy Bodies and respondents to the consultation (where practical) to confirm our decision and provide a summary of key issues raised with a clear response to each. This information will be made available online and in branch (where possible).

What to do if you feel these Principles haven't been followed:

Please get in touch so we can investigate your complaint. We'll explain in our reply whether we believe we have followed our Principles of Community Engagement and will provide you with the contact details for the relevant consumer watchdog (Citizens Advice, Citizens Advice Scotland or the Consumer Council for Northern Ireland) if you're not satisfied with our response. The watchdog will independently assess whether we have followed the Principles of Community Engagement process (rather than the decision itself) and recommend any actions with respect to the complaint.

<sup>1</sup> There may be a small number of cases where due to circumstances outside our control we have no option other than to permanently close a branch in a particular location. In these cases, the consultation will seek feedback on alternative Post Office service provision in the area.

<sup>2</sup> If the consultation includes more than four weeks in July in Scotland and Northern Ireland or more than four weeks in August in England and Wales, we will extend the period by one calendar week. We will not start any local public consultation during the two-week period which includes the Christmas and New Year bank holidays.

<sup>3</sup> Locally elected representatives include but are not restricted to the Member of Parliament, Scottish Parliament, Welsh Parliament, or Northern Ireland Assembly, Local Authority Chief Executive, Ward Councillors, Parish or Community Council.

<sup>4</sup> Selected charities are local Citizens Advice, Age UK, Northern Ireland's Disability Action and Northern Ireland's Rural Community Network. All parties referred to in <sup>3</sup> and <sup>4</sup> above are encouraged to share all information with local groups and organisations who they believe have an active interest in changes to their local Post Office.
