## Local public consultation - Have your say

## **Shaw Hall Post Office** Best One, 190 Talbot Road, Hyde, SK14 4HJ

We are proposing to move the above Post Office branch to a new location - 195 Talbot Road, Hyde, SK14 4HJ (formerly the Clarence Hotel) and subject to consultation it will continue to operate as one of our local style branches.

#### Why are we proposing this move?

As you may be aware, our postmaster's operate Post Office branches alongside their private retail business, and it is important that they make the very best use of their resources to ensure future sustainability of both their business and the Post Office service. In this case, the postmaster has identified an opportunity to move this branch into larger premises nearby. The proposed premises are currently empty and would undergo a refurbishment to incorporate a convenience store and Shaw Hall Post Office.

The postmaster firmly believes that the move would help to secure continued access to Post Office services locally, as well as supporting the viability of their business. Our priority is to safeguard our services in the locality in the longer term and the relocation of Shaw Hall Post Office would enable us to maintain a Post Office service to our customers in the local community.

#### We'd like your help

We're now starting a period of local public consultation and your feedback is important to us as it will help to inform our decision. For more details of the proposed services and accessibility, please see the branch information summary later in this consultation document.

### What exactly are we consulting on?

- How easy is it to get to the proposed new location?
- Are the new premises easy for you to get into and are they easily accessible once inside?
- Are there any other local community issues which you believe could be affected by or affect the proposed Post Office move?
- If the move were to proceed, is there anything we could do to make it easier for customers?

#### Good to know

- Customers would access Post Office services at a low-screened, open-plan, modern serving point that's part of the retail counter.
- Working with the postmaster, we'd adapt the new premises layout, fixtures, and fittings to accommodate the Post Office till if needed.
- All staff employed to work in the proposed new branch would be trained to the highest standards with on-going training on products and services, as well as operational and service-related matters.
- The current branch has an external Post Office branded cash machine, but we don't yet know whether we'll be able to transfer this facility to the proposed site.
- Access into the proposed premises would have a wide door and steps at the entrance. I am pleased to confirm that for customers who are unable to negotiate the steps, the operator would provide access to Post Office services via an alternative entrance located to the side of the proposed premises with a wide automatic door and a ramp. A bell and signage would be provided at the main entrance to allow customers to request assistance from staff. Additionally, the route to the side entrance would be kept clear and lighting and signage would be installed to ensure ease of access.
- Posters and leaflets will now be displayed in branch to let customers know about the proposal and to ask their views.
- Any information we receive will be carefully considered as we finalise our plans.
- If you are a local representative, we will write to you again at the end of the consultation to respond to the main issues raised and to explain our final plans for the branch.
- This consultation is being carried out in line with our Principles of Community Engagement which
  have been agreed with Citizens Advice, Consumer Scotland and the General Consumer Council for
  Northern Ireland the independent statutory consumer watchdogs. An extract relating to
  Consultation is available at the end of this letter.

If you are a local representative, it would be helpful if you could share this information through your social media channels and with any local groups or organisations that you know within the community, for example on noticeboards, local charities and in GP surgeries, to help our customers and your constituents understand the changes we are proposing to Shaw Hall Post Office. #### Access

Access into the proposed premises would have a wide door and steps at the entrance, however the operator would provide access to Post Office services via an alternative entrance located to the side of the proposed premises with a wide automatic door and a ramp. A bell and signage would be provided at the main entrance to allow customers to request assistance from staff.

Internally, there would be a hearing loop and space for a wheelchair.

The proposed new premises would be located approximately 75 metres away from the current branch, along mostly level terrain. Roadside parking is available nearby.

## Principles of Community Engagement on changes to the Post Office network (extract)

We are committed to engaging and supporting our customers and their representatives as we make changes to the Post Office network. The following principles will be adopted when communicating about changes to your local Post Office branch.

We will **Consult** where we are seeking feedback on proposals prior to a decision being made on the:

- Permanent closure of a Post Office branch<sup>1</sup>
- Permanent relocation of a Post Office branch (including the franchising of a Directly Managed branch to a new site)

We will carry out a six-week local public consultation, informing customers, locally elected representatives, Consumer Advocacy Bodies and selected charities of the proposal. This information will also be made available online and for a Directly Managed branch a press release will be issued to local media. We will ask locally elected representatives to share information with other key community outlets (such as notice boards, local charities, magazines, GP surgeries etc.).

The consultation will ask specific questions on areas where we would like feedback on access to Post Office services and will confirm when the change will happen if the decision is made to proceed. We will provide clear information on any changes to services as well as access to and into the new branch.

We welcome all feedback with the following factors being taken into account in making our decision, which we expect to make within four weeks of the close of consultation:

- Customer access to, into and inside the new or alternative branch/branches with particular regard to vulnerable consumers
- Any local community issues which could be affected by or affect the proposal

At the end of the consultation process we will write to locally elected representatives, Consumer Advocacy Bodies and respondents to the consultation (where practical) to confirm our decision and provide a summary of key issues raised with a clear response to each. This information will be made available online and in branch (where possible).

These Principles have been agreed with Citizens Advice, Consumer Scotland and the General Consumer Council for Northern Ireland, the independent statutory consumer watchdogs.

Please get in touch so we can investigate your complaint. We'll explain in our reply whether webelieve we have followed our Principles of Community Engagement and will provide you with the contact details for the relevant consumer watchdog (Citizens Advice, Consumer Scotland or the Consumer Council for Northern Ireland) if you're not satisfied with our response. The watchdog will independently assess whether we have followed the Principles of Community Engagement process (rather than the decision itself) and recommend any actions with respect to the complaint.

We will not start any local public consultation during the two-week period which includes the Christmas and New Year bank holidays.

<sup>&</sup>lt;sup>3</sup> Locally elected representatives include but are not restricted to the Member of Parliament, Scottish Parliament, Welsh Parliament, or Northern Ireland Assembly, Local Authority Chief Executive, Ward Councillors, Parish or Community Council.

<sup>&</sup>lt;sup>4</sup> Selected charities are local Citizens Advice, Age UK, Northern Ireland's Disability Action and Northern Ireland's Rural Community Network.
