# Local public consultation - Have your say

# Shirley Warren Post Office 93 Warren Avenue, Southampton, SO16 6AF

We are proposing to move the above Post Office branch to a new location: Thompsons, 13-15 Warren Avenue (formerly Beeston's Funeral Directors), Southampton, SO16 6AS, where it would continue to operate as one of our local style branches, where it would continue to be operated by the existing postmaster as one of our local style branches, subject to consultation.

## Why are we proposing this move?

As you may be aware, our postmaster's operate Post Office branches alongside their private retail business, and it is important that they make the very best use of their resources to ensure future sustainability of both their business and the Post Office service. In this case, the postmaster has identified an opportunity to move this branch into an alternative new location to continue to offer Post Office services to the local community. The proposed premises, which is currently empty, would undergo a full refurbishment to incorporate a convenience store with Shirley Warren Post Office.

The postmaster firmly believes that the move would help to secure continued access to Post Office services locally, as well as supporting the viability of their business. Our priority is to safeguard our services in the locality in the longer term and the relocation of Shirley Warren Post Office would enable us to maintain a Post Office service to our customers in the local community.

### We'd like your help

We're now starting a period of local public consultation and your feedback is important to us as it will help to inform our decision. For more details of the proposed services and accessibility, please see the branch information summary later in this consultation document.

## What exactly are we consulting on?

We'd welcome your comments on the following areas:

- How easy is it to get to the proposed new location?
- Are the new premises easy for you to get into and are they easily accessible once inside?
- Are there any other local community issues which you believe could be affected by or affect the proposed change?
- If the move were to proceed, is there anything we could do to make it easier for customers?

## Good to know

- Customers would access Post Office services at a low-screened, open-plan, modern serving point that's part of the retail counter.
- Working with the postmaster, we'd adapt the current store layout, fixtures and fittings to accommodate the Post Office till if needed.
- The branch would continue to offer the same range of Post Office products and services with the same opening hours.
- All staff employed to work in the proposed branch would be trained to the highest standards with on-going training on products and services, as well as operational and service related matters.
- The current branch has an external Post Office branded cash machine, but we don't yet know whether we'll be able to transfer this facility to the proposed site.
- Currently, there is a step at the entrance to the proposed premises. Works would be carried out
  at the proposed premises to remove the step and make the access level to provide improved
  access for customers. As part of the full refurbishment a new shop frontage would be installed
  with wide automatic doors.
- Posters and leaflets will now be displayed in branch to let customers know about the proposal and to ask their views.
- Any information we receive will be carefully considered as we finalise our plans.
- If you are a local representative, we will write to you again at the end of the consultation to respond to the main issues raised and to explain our final plans for the branch.
- This consultation is being carried out in line with our Principles of Community Engagement which
  have been agreed with Citizens Advice, Consumer Scotland and the General Consumer Council
  for Northern Ireland the independent statutory consumer watchdogs. An extract relating to
  consultation is available at the end of this letter.

If you are a local representative, it would be helpful if you could share this information through your social media channels and with any local groups or organisations that you know within the community, for example on noticeboards, local charities and in GP surgeries, to help our customers and your constituents understand the changes we are proposing to Shirley Warren Post Office. #### Access

Currently, there is a step at the entrance to the proposed premises, however works would be carried out at the proposed premises to remove the step and make the access level to provide improved access for customers. As part of the full refurbishment a new shop frontage would be installed with wide automatic doors.

Internally, there would be a hearing loop and space for a wheelchair.

#### Getting there

The proposed premises would be located approximately 350 metres away from the current branch, along mostly level terrain.

Limited forecourt parking would be available at the proposed premises. Further parking would be available on Laundry Road adjacent to the proposed premises. Time restricted roadside parking would also be available at Warren Crescent opposite the proposed premises.

There are local buses serving the surrounding area.

#### Principles of Community Engagement on changes to the Post Office network (extract)

We are committed to engaging and supporting our customers and their representatives as we make changes to the Post Office network. The following principles will be adopted when communicating about changes to your local Post Officebranch.

We will **Consult** where we are seeking feedback on proposals prior to a decision being made on the:

- Permanent closure of a Post Office branch<sup>1</sup>
- Permanent relocation of a Post Office branch (including the franchising of a Directly Managed branch to a new site)

We will carry out a six-week<sup>2</sup> local public consultation, informing customers, locally elected representatives<sup>3</sup>, Consumer Advocacy Bodies and selected charities<sup>4</sup> of the proposal. This information will also be made available online and for a Directly Managed branch a press release will be issued to local media. We will ask locally elected representatives to share information with other key community outlets (such as notice boards, local charities, magazines, GP surgeries etc.).

The consultation will ask specific questions on areas where we would like feedback on access to Post Office services and will confirm when the change will happen if the decision is made to proceed. We will provide clear information on any changes to services as well as access to and into the new branch.

We welcome all feedback with the following factors being taken into account in making our decision, which we expect to make within four weeks of the close of consultation:

- Customer access to, into and inside the new or alternative branch/branches with particular regard to vulnerable consumers
- Any local community issues which could be affected by or affect the proposal

At the end of the consultation process we will write to locally elected representatives, Consumer Advocacy Bodies and respondents to the consultation (where practical) to confirm our decision and provide a summary of key issues raised with a clear response to each. This information will be made available online and in branch (where possible).

These Principles have been agreed with Citizens Advice, Consumer Scotland and the General Consumer Council for Northern Ireland; the independent statutory consumer watchdogs.

What to do if you feel these Principles haven't been followed:

Please get in touch so we can investigate your complaint. We'll explain in our reply whether webelieve we have followed our Principles of Community Engagement and will provide you with the contact details for the relevant consumer watchdog (Citizens Advice, Consumer Scotland or the Consumer Council for Northern Ireland) if you're not satisfied with our response. The watchdog will independently assess whether we have followed the Principles of Community Engagement process (rather than the decision itself) and recommend any actions with respect to the complaint.

<sup>&</sup>lt;sup>1</sup> There may be a small number of cases where due to circumstances outside our control we have no option other than to permanently close a branch in a particular location. In these cases, the consultation will seek feedback on alternative Post Office service provision in the area.

<sup>&</sup>lt;sup>2</sup> If the consultation includes more than four weeks in July in Scotland and Northern Ireland or more than four weeks in August in England and Wales, we will extend the period by one calendar week. We will not start any local public consultation during the two-week period which includes the Christmas and New Year bankholidays.

<sup>&</sup>lt;sup>3</sup> Locally elected representatives include but are not restricted to the Member of Parliament, Scottish Parliament, Welsh Parliament, or Northern Ireland Assembly, Local Authority Chief Executive, Ward Councillors, Parish or Community Council.

<sup>&</sup>lt;sup>4</sup> Selected charities are local Citizens Advice, Age UK, Northern Ireland's Disability Action and Northern Ireland's Rural Community Network. All parties referred to in 3 and 4 above are encouraged to share all information with local groups and organisations who they believe have an active interest in changes to their local Post Office.
