We are delighted to let you know that following the temporary closure of St Johns Road Post Office we will be re-opening the branch on Friday 06 October 2023 at 13.00. This will be in a new location – Day-Today Express, 37 Broomhall Drive, Edinburgh, EH12 7QL where it will be known as Broomhall Drive Post Office.

We would like to hear from you

We are keen to restore services to this community as soon as possible, so we have decided to go ahead with our plans. The re-opening of the branch in a new location is a commercial decision for Post Office Ltd and we are not seeking feedback on this aspect of the change. However, we would welcome suggestions about specific aspects of the change that might benefit customers, particularly on the following areas:

- Do you have any comments about access into the new premises?
- Do you have any comments about access inside the new premises?

Details about your new branch are provided at the end of this letter and our Consultation Hub. We will be accepting comments until Wednesday 04 October 2023. We won't be responding to you individually, but any comments received will be taken into consideration as we finalise our plans.

The new premises will have a wide door at the entrance. Currently there is a step at the entrance to the premises, however a bell and signage would be provided and a portable ramp would be made available on request to assist customers whilst works are carried out to create level access. Internally, there will be a hearing loop and space for a wheelchair.

The new branch will be located approximately 800 metres away from the previous branch, along varied terrain. Roadside parking is available in front of the new premises. Public transport is available to and from the surrounding areas. The nearest bus stop is approximately 54 metres away from the new premises.

Principles of Community Engagement on changes to the Post Office network (Extract)

We are committed to engaging and supporting our customers and their representatives as we make changes to the Post Office network. The following Principles will be adopted when communicating about changes to your local Post Office branch.

We will **Engage** - where we are seeking feedback on a decision that has been made on:

• Re-opening of a temporarily closed branch in a new location (where the branch has been closed for

more than three months)

• Franchising of a Directly Managed branch in its existing site

While the decision to proceed will have already been made, we will welcome suggestions about specific aspects of the change such as access arrangements and the internal layout. We will provide four weeks' notice or, where extenuating circumstances prevent this, we will provide as much notice as possible.

During this period we will display a poster in branch and provide information online. We will contact locally elected representatives², the Consumer Advocacy Bodies and selected charities³, providing clear information on any changes to services or access arrangements at the branch. We will ask locally elected representatives to share information with other key community outlets (such as notice boards, local charities, magazines, GP surgeries etc.). We will publish the outcome of the engagement online and in branch, providing a summary of key issues raised with a clear response to each and any changes made to our original plans.

These Principles have been agreed with Citizens Advice, Consumer Scotland and the General Consumer Council for Northern Ireland; the independent statutory consumer watchdogs.

What to do if you feel these Principles haven't been followed:

Please get in touch so we can investigate your complaint. We'll explain in our reply whether we believe we have followed our Principles of Community Engagement and will provide you with the contact details for the relevant consumer watchdog (Citizens Advice, Consumer Scotland or the Consumer Council for Northern Ireland) if you're not satisfied with our response. The watchdog will independently assess whether we have followed the Principles of Community Engagement process (rather than the decision itself) and recommend any actions with respect to the complaint.
